**NOTIFICATION**

**Dated, Kolkata, the 11<sup>th</sup> day of July, 2013.**

WHEREAS in terms of provisions of sub-section (2) of section 14 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act) the Board of Councillors, unless dissolved earlier, shall hold office for a period of five years from the date appointed for its first meeting after the general election and no longer;

AND WHEREAS the first meeting of the Board of Councillors of the Municipalities mentioned in column (I) of the Table Below (hereinafter referred to as the said Table) in the districts mentioned in column (II) of the said Table against each Municipality, after the last Municipal General Election to the said Municipalities, was held on the dates mentioned in column (III) of the said Table against each Municipality, and the term of the Board of Councillors shall expire on the respective dates mentioned in column (IV) of the said Table against each Municipality;

AND WHEREAS it is not possible to hold the general election to the said Municipalities before the expiry of the period of five years specified in sub section (2) of section 14 of the said Act and in terms of provisions of sub-section (4) of section 14 of the said Act the Board of Councillors of the said Municipality shall stand dissolved after expiry of its term on the respective dates mentioned in column (IV) of the said Table against each Municipality;

NOW, THEREFORE, in exercise of the power conferred by sub-section (4) of section 14 of the said Act, the Governor is pleased hereby to appoint the Officers mentioned in column (VI) of the said Table against each Municipality as the Administrator of the respective Municipality with effect from the dates mentioned in column (V) of the said Table against each Municipality, till the new Board of Councillors of the said Municipality takes over charge after the elections to be held or until further orders, whichever is earlier:
