Dated, Kolkata, the 9th day of October, 2018

WHEREAS in terms of provisions of sub-section (2) of section 14 of the West Bengal Municipal Act, 1993 (West Ben. Act XXII of 1993) (hereinafter referred to as the said Act) the Board of Councillors, unless dissolved earlier, shall hold office for a period of five years from the date appointed for its first meeting after the general election and no longer;

AND WHEREAS the first meeting of the Board of Councillors of the Urban Local Bodies mentioned in column (I) of the Table Below (hereinafter referred to as the said Table) in the district mentioned in column (II) of the said Table against each Urban Local Body, after the last Municipal General Election to the said Urban Local Bodies, were held on the respective dates mentioned in column (III) of the said Table against each Urban Local Body;

AND WHEREAS it is not possible to hold the general election to the said Urban Local Bodies before the expiry of the period of five years specified in sub-section (2) of section 14 of the said Act and in terms of provisions of sub-section (4) of section 14 of the said Act the Board of Councillors of the said Urban Local Bodies shall stand dissolved after expiry of its term on the respective dates mentioned in column (IV) of the said Table against each Urban Local Body;

NOW, THEREFORE, in exercise of the power conferred by sub-section (4) of section 14 of the said Act, the Governor is pleased hereby to appoint the Officers mentioned in column (V) of the said Table against each Urban Local Body as the Administrator of the respective Urban Local Body with effect from the dates mentioned in column (VI) of the said Table against each Urban Local Body, till the new Board of Councillors of the said Urban Local Body takes over charge after the election to be held or until further orders, whichever is earlier:
